The Government have also prescribed the books to be introduced for Classes I and VI which have to be followed for the Compulsory Teaching & Learning of Telugu language as per this Act 10 of 2018 & the connected Rules and also follow the guidelines issued in G.O.Ms.No.36, School Education (General) Department, dt. 16.12.2017 for the safety and security of the children in the schools.
